




# INTRODUCTION

- This is said considering the legislative sector's duty towards conducting rigorous oversight of the Covid-19 Vaccine roll out in ensure that the process is fair and transparent.






# State Of The Municipality and Metro Addresses

- These dates will be communicated upon confirmation.






# DISTRICT BASED OVERSIGHT MODEL



- Considering that movement of MPLs is limited due to Covid 19, aligning with District Development Model, as part of adapting as the Eastern Provincial Legislature we have adopted and piloting a strategy of **District Based Oversight Model (DBOM)**
- The implementation of the DBOM had to be accelerated due to the COVID-19 pandemic as a means to maintain trajectory of the oversight function;
- In the up-coming financial year, the we intend to refine and **prioritise the DBOM** to enhance oversight on the implementation of the District Development Model.




# COVID 19 RESPONSE



- In 2021 a focused response to the second (and possible third) wave of Covid-19 continues to be a priority. In this regard, the we will prioritise oversight on the roll out of the Covid 19 vaccine, as well as the Education Sector's readiness to operate within the context of the virus resurgence and mutation trends.
- Within the Legislature we have enhanced COVID-19 response task team, and has developed a work plan that will ensure adherence to COVID-19 regulations within the workplace, while improving effective performance by the institutions.
- To this end, all meetings of Committees, study groups, Caucuses, House-sittings continue to be held virtually and / or hybrid setting subject to the regulations of Covid alert levels and regulations.




# OVERSIGHT



- In this year will continue to prioritize robust oversight that will ensure responsiveness and accountability of the government to the people of the Province.
- This is done through application of SOM to the latter by consideration of budget votes, oversight visits, consideration of Bills as well as monitoring progress towards the attainment of the PDP targets.
- Our flagship programs are inclusive of the **Schools Visits Program** will be enhanced to include monitoring schools adherence to Covid-19 regulations.
- **Oversight on Covid-19 programs** will continue to be conducted by the Health Portfolio Committee, whilst the Legislature Oversight Committee will focus on ensuring oversight by the Legislature.




# PUBLIC PARTICIPATION



- Given that 2021 is an election year, it is crucial for the Legislature to ensure meaningful public involvement, education and advocacy so that citizens participate meaningfully in all processes of democracy.
- Public and Voter education will be driven through the District Based model and other outreach programmes of the Legislature. Partnerships with other government departments and stakeholders will be enhanced to ensure maximum impact of programmes promoting citizen participation.
- To enhance public participation processes the following programs will be held:
  - **Two sectoral Parliaments**
  - **Taking Legislature to the People 1<sup>st</sup> – 5<sup>th</sup> November 2021**
  - **Nelson Mandela International Day**




# PUBLIC PARTICIPATION



- This year will prioritise the realisation of Legislature as **an activist and people-centred institution** which thrives on engaged public participation; robust oversight and effective law making.
- In order to effectively service constituencies, the Legislature has adopted a policy position that that **Parliamentary Constituency Offices (PCOs) are an extension of the Legislature; and as such, it is imperative that all services offered by the Legislature are accessible to communities in the PCOs.**
- Through PCOs the Legislature will ensure a synchronised and coordinated approach to governance and mass mobilisation, by bringing the Legislature closer to the people and mobilising organs of people's power.




# LAW MAKING



- A key constitutional imperative is that of facilitation of public involvement in the processing of Bills. This facilitation of involvement in the legislative processes is critical.
- Key to note is that the ECPL is in the process of **finalisation of the Money Amendment Bill** and this will be prioritised this year and we will continue with the process of repealing old repressive laws.
- For processing of other bill we are further dependent on the NCOP on the number of Bills to be considered in any given financial year. In this regard, an estimate of 4 Bills has been planned for the 2021/22 financial year.




# Office of the Chief Whip Programs Priorities for 2021/22



- To work with the Legislature and other social partners to defeat Covid 19 by conducting vigorous oversight on roll out and ensure that PCOs disseminate and publicise information on the efforts of government and required social change.
- Finalise and implement the MPLs performance matrix and produce an annual report for assessment of the work of each committee and individual MPLs.
- To prepare for the Local Government Elections and in the immediate, and to ensure that PCOs are ready to operate as elections operational nerve centres.
- Raise the profile of the Legislature and government thus intensify Sectoral outreach and Provincial Chief Whip Forum
- Intensify communications, Public Relations and the Battle of Ideas




# Office of the Chief Whip Programs Priorities for 2021/22



- Ensure that the Legislature is an activist and people-centred institution which thrives on engaged public participation; robust oversight and effective law making.
- Mobilise community involvement and participation on the key pieces of legislation and bills which will be passed into law before local government elections.
- MPLs (through their PCOs) to play an active role in deepening democracy and the culture of human rights.
- PCOs to be much more involved in conducting oversight by ordinary people submitting questions for written and oral reply and submitting petitions to be escalated to the Legislature and Executive.




# ICT ENHANCEMENT



- With the outbreak of COVID 19 and the subsequent announcement of the lockdown levels by the President, a drastic demand of the ICT services and change of systems in the manner in which the Legislature conducts its business proved the necessity of **ICT infrastructure and facilities to enable and support the work of the Legislature.**
- **The focus will be on installation of the ERP** and related systems which will improve the internal control environment, improve efficiency and pave the way for greater digitalization of Legislature business processes.




# CONCLUSION
