### **BRIEF BACKGROUND**

- CHDM is Category C municipality situated in the north-eastern part of the Eastern Cape, a linking node to all regions in the province.
- Bordered by the Joe Gqabi District to the north, Cacadu and Amathole District to the south, OR Tambo District to the east, and Northern Cape to the west.
- 2<sup>nd</sup> largest district in the province, making up almost a third of its geographical area.
- Comprises six local municipalities: Inxuba Yethemba, Enoch Mgijima, Intsika Yethu, AB Xuma, Sakhisizwe and Emalahleni.
- The current statistics of the District depicts that there are 452 780 females and 419 685 males.



## **DISTRICT GENDER MACHINERY**

There are structures are in place within the district and local municipalities focusing at advancing the gender equality agenda and these include:

## **Women's Forum (Special Programmes Unit)**

- ☐ The Women's Forum has been established at the district level
- ☐ Four LMs have already established theirs with two other LMs due to sit in October to establish these.

## Women's Caucus (Office of the Speaker)

☐ The committee deals with women's issues across the district and ensures quarterly sitting of district women's caucus meetings and Women Caucus Chairpersons from Local Municipalities



## **WOMEN'S FORUM FUNCTIONALITY**

- The District Women's Forum is functional, sits on a quarterly basis and was elected in 2018 comprising representatives from all local municipalities.
- ☐ The structure is due for re-election and focuses on the following:
- Coordination and implementation of women's programmes in the district
- Advocate for the implementation of women's programmes in the district working closely with SPU.
- Ensuring participation of women in the development of responsive programmes targeting women in the district.
- A gender mainstreaming strategy and implementation plan is in place and currently under review.
- ☐ The structure is budgeted for within the budget of the Special Programmes Unit to ensure gender mainstreaming in programming.
- □ Various programme initiatives have been carried out in an organized and consistent manner across the different initiatives with clear coordination, resulting in sector-wide impact in partnership with local municipalities and relevant stakeholders. These initiatives include:

#### **LED PROGRAMMES**

- CHDM has made a noticeable dent through Local Economic Development programmes
  with women as beneficiaries and receiving support in some of these to root out
  joblessness in many parts of the district.
- The district is currently implementing various programmes ranging from Tourism,
   Heritage and Agriculture where women are also participants.
- There are **Irrigation schemes programmes** such as vegetable production which benefits women and the majority of Co-ops are led by women: CDHM annually provides a budget allocation of R750 000.00 towards these.
- On **Grain producing programme** (Rafi) has women Co-ops that are benefiting, where the district invests R1 million annually.
- Heritage events are largely led by women and these are supported annually, where the
   district invests varying amounts but current year is R1,8 million



## **LED PROGRAMMES**

- **Skills training programmes** through various SETAs benefit learners whom females are a majority.
- Food security programme where women are supported with vegetable seedlings, piggery, poultry and animal feed each year, with varying investment from R200 000 to R500 000 each year.
