Isikhabelelo somThethomlingwa omayelana neenSelo ezinoTjwala [B10-2016] unqophe ukukhabelela umThetho wemiKhiqizo yoTjwala, umthetho womnyaka we-1989 (umthetho we-60 womnyaka we-1989), ukwenzela ukufaka, ukukhabelela nokucima ezinye iinhlatululo; ukwenzela ukuthiya nokubiza kabutjha nokwenza kubesemthethweni iBhodi yezamaWayini neeMpiridi nokwenzela ukubeka imikhawulo yamandla wayo; ukwenzela ukufaka imibandela mayelana notjwala, utjwala besiNtu obungebemVelo kunye nezinye iinselo ezenziwe ngengumelo neembiliso zotjwala; ukukhipha nokwenza kube nokulungela kubesemthethweni ukusetjenziswa kwezinye iinselo nemikhiqizo enotjwala; ukunikela uNgqongqotjhe amandla ukubeka umuntu neziko elizokukhupha iintifiki zokurweba nokuthengisela iinarha zangaphandle; ukwenzela ukurhemisa ngefanelo ezinye iindima ukukhambisana nomThethosisekelo; ukwenzela ukungezelela amandla kaNgqongqotjhe ukwazi ukwenza imigomo yokulawulo; ukwenzela kube nokubunjwa kwamathemu wokulingana ngobulili; nokwenzela ukutjheja ezinye iindaba ezikhambisana nalokhu.
