# **National Assembly**

#### The Speaker

#### 1. Membership of Assembly

#### The Chairperson

#### 1. Referral to Committees of papers tabled

- (1) The following Executive Undertakings are referred to the **Select Committee on Petitions and Executive Undertakings** for consideration and report.
  - 1. Minister of Public Works and Infrastructure: During the Sittings of 25 May 2022, the Minister made the following undertakings:
    - (a) Our department's resources will focus on the current 53 government-owned buildings in KwaZulu-Natal and 12 government-owned buildings in the Eastern Cape to make them usable."
    - (b) "The number of bridges that will be constructed in terms of the 96 are: eighteen bridges in the Eastern Cape, 18 in KwaZulu-Natal, 11 in Mpumalanga, 11 in Limpopo, 10 in the Free State and 10 in the North West."
    - (c) "For the new financial year, the department plans to release 7 100 hectares for human settlements, another 180 hectares for

- socioeconomic purposes and 1 400 ... 745 hectares under land reform for restitution and also land tenure."
- (d) "Under the programme of Human Settlements, we plan to release 7 100 hectares. The breakdown per province will be 502 hectares for the Eastern Cape, 5 160 for KwaZulu-Natal, 0,6 hectares for the Northern Cape, 50 hectares in Limpopo, another 1 144 hectares in the Western Cape, 21 hectares in Mpumalanga and 258 hectares in the Free State."

# 2. Deputy Minister of Cooperative Governance and Traditional Affairs: During the Sittings of 1 June 2022, the Minister made the following undertakings:

- (a) "We will pay greater attention to our risk mitigation parts of our disaster management strategies. Thus, as part of the third phase of building back better, we are identifying and securing public land we can utilise to resettle the affected communities."
- (b) "In this financial year, through the Municipal Infrastructure Support Agent (Misa) we are training 500 municipal officials in the requisite technical skills whilst enrolling another 100 officials in the recognition of prior learning programme."
- (c) "These will be complemented and supported by the 300 young people who will this year participate in our apprenticeship, experiential learnership and young graduate programme"

# 3. Minister of Public Enterprises: During the Sittings of 9 June 2022, the Minister made the following undertakings:

- (a) "The second very important challenge is poor coal quality, which is often caused by syndicated coal delivery and causes major damage to boilers and the plants at power stations. Eskom is seeking collaboration with the coal mining industry to solve this problem."
- (b) "In terms of corrupt procurement, there are several syndicates that are involved in the delivery of coal, in the delivery of fuel, oil and other supplies, including spares. Measures are being taken to identify the insiders who are enabling syndicates to gain access to ... the opportunity to steal."
- (c) "At selected power stations, war rooms will be set up to ensure that production challenges are tackled in a systemic, but immediate and agile way."
- (d) "Twelve substations across four provinces the Northern Cape, Western Cape, Eastern Cape and Free State will also have to be constructed and 110 transformers to deliver network strengthening requirements up to 2030 would be required as well."
