EXTENSION OF THE EMPLOYMENT OF MEMBERS OF THE SOUTH AFRICAN NATIONAL DEFENCE FORCE FOR SERVICE IN FULFILMENT OF INTERNATIONAL OBLIGATIONS OF THE REPUBLIC OF SOUTH AFRICA.

This serves to inform the National Assembly that, I have extended the employment of Two Hundred (200) members of the South African National Defence Force (SANDF) for service in fulfilment of the International obligations of the Republic of South African towards Southern African Development Community maritime security, in order to deter and prevent piracy in the Mozambique Channel.

Members of SANDF employed will continue to counter piracy in the Mozambique Channel.

Members of SANDF employed will continue monitoring and deterring piracy activities along the southern African Coast of the Indian Ocean.


The employment was authorised in terms of section 201(2)(c) of the Constitution of the Republic of South Africa, 1996.

This extension of the employment is for the period 01 April 2018 to 31 March 2019.

The total expenditure expected to be incurred for the employment is R 127 000 000.
