and indeed the deep contradictions of our society and history. Seventy-eight years ago, on 26 May 1948, in an electoral system reserved exclusively for white voters, the National Party won most seats in the House of Assembly. That victory paved the way for the legislative machinery of apartheid, intensifying racial segregation and stripping most of the people of this land of their rights and freedoms. The scars of that machinery are still visible in our society today. Its fault lines continue to mark where people live, how they move, what opportunities they can access, and how freedom is experienced in their daily lives. Not far from us here, District Six is a living reminder of the effects of the Group Areas Act. President Nelson Mandela later characterized our country's situation with unmatched clarity when he described us as a country that was a pariah amongst nations. A detestable example of what is impermissible in the ordering of human relations and homeland of a crime against humanity.

This week also carries the triumphant weight of history. On 25 May 1994, the United Nations Security Council adopted Resolution 919, terminating the arms embargo and ending the remaining sanctions against South Africa. This marked the end of South Africa's isolation following the 1994 democratic

elections. It also marked our democratic nation's formal admission to the family of nations.

It is also fitting that yesterday, 25 May, we marked Africa Day. Indeed, as we table this budget of R7,227 000 000 for 2026-27, we do so with full awareness of this history. It is a history of pain whose consequences remain with us and a history of victory that gave our democracy a great responsibility to conduct foreign policy anchored in Ubuntu, justice, international law, dialogue, multilateralism, and the needs of our country and of our continent. In the 32 years of our democratic dispensation, successive democratically elected governments have been at the center of concretizing the achievements of our equality through legislative and other measures designed to protect or advance persons or categories of disadvantaged by unfair discrimination. We table this budget at a time when international co-operation is under sustained pressure from unilateralism, economic cohesion, wars of aggression, deals of extraction, and a winner-takes-it-all approach to global relations. South Africa cannot afford to shed the responsibility that comes with its history. Our freedom is a product of international solidarity. South Africa must, in this moment, continue to discharge three tasks

towards a better Africa and a better world. Africa is the centrepiece of our foreign policy. Our first task is to advance the interests and the voice of the African continent. This task begins with the pursuit of a stable, integrated, economically resilient Africa. Our diplomacy across the continent promotes bilateral relations, deepened regional co-operation, and collective alliance efforts around shared development priorities.

As chair of the AU Ministerial Committee on the follow-up and implementation of Agenda 2063, South Africa has a responsibility to support the continent's decade of acceleration with greater agency, stronger institutions, and the shared ownership of Africa's development agenda. Our nomination to the committee of Heads of State and Government on the implementation of the African Continental Free Trade Area, AfCFTA, also reflects confidence in South Africa's commitment to continental economic integration. The AfCFTA must become a practical instrument for expanding intra-African trade, building regional value chains, advancing industrialization, and creating jobs. The AfCFTA has the potential for a common market of US\$3,4 trillion and a pathway to diversification, reduced dependency on external markets,

and greater resilience of our economies. Yet intra-Africa trade remains too low, at just 16% for the continent and 21% for the Southern African Development Community, SADC, region. This is far below Europe at 68% and Asia at 59%. Africa's trade is also still heavily concentrated outside the continent. Over 50% of the continent's imports and exports are tied to just five economies, all outside Africa. This is the source of our vulnerability to external shocks. It is also why regional integration must move from aspiration to implementation.

I have recently hosted the SADC Ministers of Foreign Affairs Retreat in Skukuza, in the Kruger National Park, where Ministers reflected on the geopolitical developments affecting our region. The Ministers agree that SADC must be better prepared to respond to external shocks, whether they arise from conflict, climate disasters, food and fuel price volatility, public health emergencies, or the decisions of powerful actors far beyond our borders. Our region is home to 30% of the world's proven critical mineral reserves. We are also home to approximately 50% of the world's cobalt reserves, 20% of the world's graphite reserves, and 10% of the world's copper reserves. These resources, if harnessed properly, can

propel our region's structural transformation. Countries in our region, including South Africa, Zimbabwe, Botswana, Namibia, and Tanzania, are taking bold policy steps to ensure that mineral endowment supports development. In our country, it has come through the critical mineral strategy. When South Africa assumes the full chairship of SADC in August 2026, our priorities will include deepening political cohesion, consolidating the SADC free trade area, reducing non-tariff barriers, and building regional value chains in agro-processing, critical minerals, beneficiation, pharmaceuticals, and other strategic sectors.

An integrated Africa cannot be built on conflict and instability. That is why our continental task also extends to peace and security. South Africa serves on the AU Peace Security Council at a time when parts of the continent continue to face armed conflict, unconstitutional changes of government, terrorism, violent extremism, and transnational organized crime. In the Great Lakes region, we continue to support efforts towards a political solution to the conflict in the Eastern DRC. In South Sudan, we will continue to support dialogue, institutional reform, and the full implementation of the revitalized peace agreement. South

Africa also maintained its principled support for the right of the people of Western Sahara to self-determination in line with international law and United Nations resolutions. In all these areas, South Africa discharged its responsibility through diplomacy, mediation, regional solidarity, and a firm belief that Africa must shape its own future. We are antiwar and advocates for peace.

Our second task is to champion the reform of global governance and defend international co-operation. The world is changing, but many of these institutions still reflect old patterns of power. Developing countries continue to face unsustainable debt, unequal access to development finance, and growing pressures to align with powerful geopolitical blocs. South Africa's responsibility is to advance a fairer and more representative global order. This means continuing to call for reform of the United Nations, especially the Security Council, so that it can respond more effectively to contemporary global challenges. South Africa's G20 Presidency, under the theme of "Solidarity, Equality, and Sustainability", gave expression to this responsibility. Amongst the important outcomes of our Presidency were two major reports, the G20 Africa Expert Panel Report on Growth, Debt, and Development: Opportunities for a

New African Partnership and the report on the G20 Extraordinary Committee of Independent Experts on Global Inequality. We continue to work with partners, including AU, Brazil, Norway, and Spain, towards establishing the International Panel on Inequality, for which endorsement by the UN General Assembly is being sought later this year. In addition, the AU Assembly of Heads of State and government has adopted a decision profiling the key deliverables of the Johannesburg Summit, including the establishment of a G20 Continental Co-ordination Mechanism to strengthen coherence amongst the AU, UN, and G20 processes. Through BRICS, South Africa will continue to advance reform of global governance institutions and support the development of the new BRICS Economic Partnership Strategy. The expansion of BRICS to 11 members marks a significant milestone in the growing voice of the Global South in international affairs. It must also defend the rules that protect all nations, large and small. We have formed a group to defend the credibility of international law, hold states accountable for breaches, and protect the integrity of the international legal order. It was established to rally against complicity and impunity and support the collective enforcement of international law through concrete measures, including halting arms transfers, blocking weapons

shipments, suspending procurements from Israeli firms, seizing energy exports, and pursuing accountability through national and international courts.

As a country that voluntarily dismantled its nuclear weapons programme, we continue to advocate for the total elimination of nuclear weapons, and we will preside over the first review conference of the treaty on the prohibition of nuclear weapons later this year.

Our third task is to use foreign policy as a lever to improve conditions at home. Foreign policy must ultimately speak to the lives of our people. Our foreign policy must support inclusive economic growth, poverty eradication, sustainable development, peace, and security. Our economic diplomacy is yielding results. As we speak today, 45% of our processed goods, including agricultural goods, are now traded within the continent. In 2025, South Africa's agricultural exports reached a record of US\$15,1 billion. In the first quarter of 2026, farm exports reached US\$3,7 billion, an increase of 11% year-on-year. This creates jobs at home in the processing plants and factories, including the logistic networks. These exports reach markets across Africa, the European Union, and

Asia. They show how foreign policy can support jobs, production, and economic opportunities at home.

On migration. This means managing migration lawfully in a co-ordinated manner and based on evidence, data, and statistics. The law enforcement authorities must enforce the law regarding irregular migration, not private citizens. The police, border management, and labor inspectors must play their role. It means the protection of the fundamental rights of every person, secure borders, and an immigration system that is insulated from corruption. In line with President Ramaphosa's commitment as the pandemic preparedness champion of the African Union, South Africa will contribute US\$5 million to the Africa Centres for Disease Control and Prevention, CDC, to help with the fight against Ebola, as hon members are aware of the outbreak in most parts of West Africa and some parts of East Africa, and in the DRC.

Let me conclude by returning once more to President Mandela, who reminded us that because ...

As the portfolio committee, we've got some proposals that we want to make to the department. will become economic colonies in the 21st century. Modern warfare is no longer fought only with tanks and missiles and drones.

Wars are now fought through sanctions, trade routes, cyber warfare, AI systems, food supply chains, financial systems, media narratives, and technological dependency, and South Africa is now directly caught in those global battles. We have seen growing tensions with the United States, with our ambassador kicked out, our President summoned and falsely accused in the Oval Office of white genocide. We have seen threats around AGOA based upon widely debunked white genocide and Africana refugee programme, which is belacheliking, so to say.

We have seen tariff wars escalating globally; we have seen attempts to succeed Western Cape from South Africa as a sovereign state; we have seen the weaponisation of sanctions and international financial systems. We have seen South Africa dragged into the centre of the geopolitical storms following the International Court of Justice, ICJ, genocide case against Israel, and yet despite all of this, Budget Vote 6 still behaves as it's a normal world. It is not a normal world. The

Department of International Relations and Co-operation still operates with a diplomatic philosophy designed for 1994 while the world has moved into 2026.

The department still measures success through meetings held, forums attended, reports compiled and protocol ceremonies. But our people do not eat meetings; young people do not find jobs through diplomatic photo opportunities and township businesses do not enter export markets through conferences. South Africa's expanded unemployment rate now exceeds 41%. Youth unemployment remains above 45%. More than 18 million of Africans survive through social grants, which is not enough, and yet this Budget Vote gives the Department of International Relations and Co-operation roughly a two percent increase, an increase already swallowed by inflation and currency volatility.

At this very precise moment, global geopolitical competition is intensifying. South Africa is shrinking diplomatic capacity because of austerity budgets, and this is from the Government of National Unity, GNU. That contradiction is dangerous. The Department of International Relations and Co-operation cannot simply remain a protocol department. Every South African

embassy abroad must become an economic command centre for national development. Besides normal embassy and consular services, every ambassador must become an economic field marshal for investment attraction, technology transfer, industrial scholarships, skills development, market access and tourism expansion.

We need to stop asking how many meetings were held and saying, how many jobs we created; how many export contracts were signed; how many towns did your businesses entered global markets; how many industrial partnerships were secured for black business and how much investment actually reached the poor communities. That is the true measure of the diplomacy and of the Department of International Relations and Co-operation's success. South Africa is not a poor country; we are poorly structured in our economy, sitting on immense strategic wealth, like the Minister said, we control over 70% of the world's platinum reserves and we sit on the most important maritime trade routes on earth to the Cape Sea Route.

We possess massive, untapped oil and gas potential, and yet, despite this wealth, millions of people still live in abject

poverty, live in shacks for 30 years like animals, without employment and complete hopelessness, because the mandate of the Department of International Relations and Co-operation hasn't translated into a better life for all. This is because South Africa still operates inside a colonial economic structure where raw material wealth leaves our shores while poverty remains behind. For centuries Africa exported all our stuff, gold, diamonds and cobalt.

We exported everything and we imported finished products, and this meant that there are no jobs for our people; there's just poverty for our people. In this particular department, when I went to all the events at the embassies in China, Europe and everywhere, all I saw was white monopoly capital; all I saw was the Johannesburg Stock Exchange, JSE, people, standing there and they were getting the businesses, and they were getting the opportunities. But you don't see black, young people there; you don't see black women there; you don't see black disabled people there; you don't see coloured businesses there and you don't see Khoi-San businesses there.

You only see the same system that has been running this country the last 30 years, which is the same extractive model

that was still in place from apartheid right up until now. While China built the entire future cities and the industrial corridors for R1,4 billion and the India does the same, South Africa debates austerity, and we only have 65 million people while the department's vacancies have been frozen and our municipalities fail, and there are no support from our partners who are willing to give us support in the BRICS environment.

We can get funding from China, and we get funding from the New Development Bank, but we refuse to do that; we refuse to take loans from the International Monetary Fund, IMF with conditionalities. That means we've got to cut, cut, cut instead of grow, grow, grow.

What we need to do is grow the economy, and we need to use the Department of International Relations and Co-operation to do that. We should not be managing decline; we should be building an African economic powerhouse. A 2% increase will not fix the information communication technology, ICT, problems, in the Department of International Relations and Co-operation; it will not help solve the problem of embassies which are dilapidated or consular services weakened by frozen vacancies,

and there is no budget to take delegations of black businesses, youth entrepreneurs and women to our foreign missions and to all these great amazing exhibitions and things that can actually take the products and sell it in those places.

You don't see that happening. Why has it not happened for 30 years? The MK Party supports Pan-Africanism, African industrialisation, Brics co-operation and we are saying that enough is enough. We must make South Africa first; that must be our motto. You must put the poorest of the poor first. The Department of International Relations and Co-operation mustn't cater for the elites; it must cater for the poor. Right now, the Department of International Relations and Co-operation is not catering for the poor; it's only catering for the people who have the money and who have the wealth.

In Zambia, we don't even own our residential accommodation or chancery. Those who are not willing to respect South Africa must go to hell, literally, because an African Renaissance Fund that places the burden of Africa on South Africa's shoulders while other governments destroy their own countries through corruption, instability and poor governance is a scam. We are funding election observation missions while South Africans sit unemployed. Why are we not using those resources to drive trade, infrastructure and economic projects through the African Free Trade Area Agreement so that South Africa benefits economically from its leadership role on the continent?

Last year, 14 South African soldiers died in the Democratic Republic of the Congo, DRC, in the name of peacekeeping.

Fourteen lives lost, families shattered, and coffins draped in the South African flag. And what happened afterwards? The DRC and the United States signed agreements giving American

companies priority access to the DRC's vast mineral wealth. America secured the deal. South Africa buried the soldiers. That cannot continue. The world has changed. Global politics is no longer about charity. It is about interests. It is about influence. It is about economic power.

South Africa must stop using state taxpayers' money to be the messiah of the African continent while our communities collapse under unemployment, crime and illegal immigration. The Government of National Unity, GNU, speaks about renewal, but its statement of intent is dangerously vague on foreign policy. That conversation was ignored during coalition negotiations, and now is the time for the country to have that, and we are paying the price for that silence. I thank you. Thank you.

Dr M A MAIMANE: House Chairperson, we gather on this day, post the celebration of Africa Day, and I wanted to reflect just on a few matters that speak to our foreign policy. On the first instance, if it is indeed true that our foreign policy must be based on human rights and trade, the first objective that we've all got to be focused on is the fact that Africa still only represents 3,5% of global GDP. to the fact that we are the fastest-growing continent as far as population growth is concerned. By mid-century, we will have over 1,4 billion people.

If we think we have an immigration crisis now, we must appreciate that if we fail to grow Africa's economy as brothers and sisters, we will be doomed to face the challenges of a future that is coming. Secondly, Minister Lamola, I want to state to you quite categorically that I was in India recently and I met our high commission there. Part of the dilemma is the capacitation and vacancies there; includes South Africa exports many of its agricultural products to India, and yet there was no staffing that was focused on the Agricultural Council. That is a limitation that limits our ability to trade with nations such as India. If we learn anything from the Indian economy is that they've successfully managed to move at least over R250 million people from poverty, which is a lesson that we ought to be learning.

Thirdly, hon members, many people have come to blame our Constitution when it provides, in section 27, that the government fails to do the basics in health care. Multilaterally, of course, the Minister, our chief advocate, when you look at the Indian Ocean Rim Association, IORA, you look at the Zone of Peace and Cooperation of the South Atlantic, Zopacas, you look at G77, China, and you look at Brics, across all three pillars, both political security co-operation, financial and economic cooperation, your people-to-people mechanism. That is the key mandate of the Minister of International Relations and Co-operation. in Brics. Budget Vote 6 is less about the line items and allocations enclosed in this year's Appropriation Bill, and more about the critical mandates of this department which remain unfunded. One such mandate is the upkeep and maintenance of South Africa's foreign assets, namely, our embassy buildings and properties which house our foreign missions and diplomatic staff.

Last year the Auditor-General's Budgetary Review and Recommendations Report, BRRR, revealed that Dirco had financially regressed over the 2024-25 financial year. This regression is partly due to damning findings pertaining to Dirco's asset management process, particularly the management of state-owned properties abroad for diplomatic use.

The decline of South Africa's embassy buildings and international properties is rampant, dire, and highly underreported. Multiple reports have stated that South Africa House in the United Kingdom has no water or heating, with staff often having to work from home. There are further reports of priceless artworks and artifacts having gone missing. Just recently I was told by a London resident that a

local vagrant has taken up residence outside the High Commission's front door.

In Mozambique, five to six staff members have to share one laptop. There are no reliable phone lines, let alone any internet access, and consular services are crippled by a lack of basic embassy support and equipment. How is South Africa supposed to craft an investible image when our embassies resemble the very same broken local municipalities under the ANC?

I wasn't aware that a revolutionary budget meant undermining our embassies and embarrassing our nation on the international stage, but not much can be expected from a Minister who, over the last five oral cluster question sessions, has only attended one – virtually. You may be the chief diplomat, Minister Lemola, but Parliament is not optional.

While the mandate to maintain South Africa's foreign assets was previously transferred to Dirco from the Department of Public Works, there was no transfer of a budget, nor of any skills to carry it out. Essentially, South Africa's embassy buildings and foreign assets are not only in a state of

We welcome the R2 trillion that the Sars has now been able to receive. It shows that there is efficiency, and in future the challenges of budget constraints can be resolved for the Department of International Relations and other relevant departments.

It is not true that the Brics Bank or the Development Bank of Brics has not been able to fund projects in our country. We have used amounts from the Brics Bank to resolve challenges in infrastructure, particularly in the network industries, rail, water and other critical infrastructure projects to the tune of about \$7 billion. So, we, as a development partner within the Brics family, are one of the beneficiaries of this bank.

Furthermore, as a country, we are being criticised by some of the GNU partners who are working with us that we are non-aligned. We have continuously been consistent, hon Ryan Smith, that our active nonalignment has been very consistent. We have been clear that it has been anchored on the UN Charter, on the human rights outlook, and we have done so across all the platforms in terms of our consistency in this regard. We will not be deterred from doing so.

Hon Ryan Smith has raised most arguments that come from the Make America Great Again movement, Maga movement, in the US. He has elevated these concerns of transformation in our country, and everyone in South Africa agrees and understands that BEE is a critical pillar of our transformation. It is in the Constitution of the Republic, and all our transformation efforts are fully anchored on our constitutional democracy.

We know that in the US, the Maga movement is very clear: It exists to attack black people. We know what they stand for. They stand against the human rights of women and the LGBTQI communities. The Maga is driven by a particular ideology. Is hon Ryan Smith aligning the DA with this position? Is he part of this movement that is against human rights and against
