In light of the fact that the South African economy and the economies of other African countries have been severely affected by the Covid-19 pandemic which resulted in an international lockdown to curb its spread, disrupting domestic and international trade and bringing many industries such as travel and tourism to the verge of collapse as well as stalling the timetable for the implementation of the African Continental Free Trade Agreement, (a) what measures has the Government put in place to accelerate the recovery of the South African economy and (b) how is he coordinating the economic recovery in Africa as the Chair of the African Union?
