Whether, as Leader of Government Business, he has taken any steps to ensure that members of the Executive fulfil their obligations to be accountable to Parliament in terms of section 92 of the Constitution, 1996, by (a) arranging that they attend to their parliamentary business, (b) monitoring and (c) reporting on unanswered parliamentary questions; if not, why not; if so, (i) what steps and (ii) what are the further relevant details?
