### **CLUSTER 2: SOCIAL SERVICES**

#### ★411. Mrs N R Mashabela (EFF) to ask the Minister of Social Development:

In light of how children living with disabilities and autism are often overlooked when it comes to early childhood development (ECD) programmes, what (a) steps has she taken to provide such children with access to a stimulating ECD phase, and (b) is the total number of ECD centres with trained practitioners for children with special needs in the Republic? # ★372. Ms N T Mkhatshwa (ANC) to ask the Minister of Higher Education, Science and Innovation:

What steps has he taken to address the lack of accountability in the administration of the National Student Financial Aid Scheme (NSFAS) which results in poor disbursement of funds, slow accreditation of accommodation, unjust defunding of students and a lack of response to appeal queries that have led to the previous interventions of placing NSFAS under administration and investigations by the Special Investigating Unit?
