Whether his department has started implementing the interventions that were announced by the President regarding Eskom (details furnished); if not, why not; if so, (a) when, (b) when is the entity expected to be stable and (c) what are the further relevant details? CO129E

*Power supply crisis in KZN ward***★18. Mr T J Brauteseth (KwaZulu-Natal: DA) to ask the Minister of Public Enterprises:**

- (1) Whether he has any plans to urgently intervene in the dire situation that involves the community of ward 99 in Mkomazi in KwaZulu-Natal which has been plagued with erratic and sometimes non-existent power supply from Eskom over the past five years (details furnished); if not, why not; if so, (a) what plans and (b) what are the further relevant details;
- (2) whether he will instruct Eskom officials to meet with him in ward 99 in order to address such a challenge; if not, why not; if so, (a) when and (b) what are the further relevant details? CO123E
