**★118. Ms M M Ntuli (ANC) to ask the Minister of Public Service and Administration:**

(a) What progress has been made with regard to wage negotiations and bargaining between his department and public sector unions and (b) has he envisioned a time frame of the date on which the specified matter will draw to a conclusion? NO894E

**★130. Mr C H M Sibisi (NFP) to ask the Minister of Public Service and Administration:**

What steps will he take to fast-track the implementation of the Government Employees Housing Scheme since most employees do not qualify for bonds and reconstruction and development houses? NO907E

**★120. Ms M T Kibi (ANC) to ask the Acting Minister in The Presidency:**

With reference to the various monitoring and evaluation tools utilised by her Office when conducting monitoring in government departments and municipalities, (a) how effective has she found are the specified tools in identifying shortfalls in implemented government programmes and (b) do the tools offer recommendations to mitigate the challenges experienced by her Office? Whether her Office has conducted its own investigations and instituted disciplinary hearings against the suspended spokesperson of the President, Ms Khusela Diko; if not, (a) what has caused the delays in this regard and (b) on what date will the President have a full-time spokesperson to facilitate communication with the media; if so, what are the further relevant details? With reference to the fact that the majority of municipalities are experiencing a decline in revenue and cash collection that has been exacerbated by the COVID-19 pandemic, what steps has her department taken to assist the struggling municipalities to ensure uninterrupted service delivery to communities?
