# **DEPUTY PRESIDENT**

#### **1.** Ms D R Direko (ANC) to ask the Deputy President:

(a) How successful has he found the Government's programmes to be which stimulate and support rural and township economies, using specific empowerment models that predominantly rely on a system of integrated local government support as a catalyst for fundamental socio-economic transformation and development of these economies and (b) in light of the evidence that has emerged, what needs to change in local government in their support for such initiatives? #### 2. Ms N W A Mazzone (DA) to ask the Deputy President:

Whether he will meet with Ms N W A Mazzone, with reference to the statement of the President of the Republic, Mr M C Ramaphosa, in his reply to the debate on the State of the Nation Address on 20 February 2020, that we will not succeed in building a better South Africa if we do not all work together, in order to discuss proposals for urgent solutions and immediate structural reforms necessary to fundamentally restructure the Republic's electricity industry, in order to achieve a secure supply of reliable, affordable and sustainable energy?
