★1. Mr S Luzipo (ANC) to ask the Deputy President:

What financial and technical interventions, including the reduction of debt owed by municipalities, is Government making to restore Eskom as a going concern that is able to reduce load shedding to facilitate inclusive economic growth and job creation? NO840E

★2. Ms S Gwarube (DA) to ask the Deputy President:

What are the details of his priorities as Leader of Government Business to ensure that (a) Members of Cabinet attend to their parliamentary duties, such as attending meetings of parliamentary committees and plenaries to answer questions for oral reply, and (b) the parliamentary business initiated by the Executive, is programmed, such as the introduction and processing of legislation before the end of the Sixth Parliament? ★3. Ms NV Mente (EFF) to ask the Deputy President:

Whether the unanswered questions arising from the break-in and theft at the Phala Phala farm of the President, Mr MC Ramaphosa, the findings of the South African Revenue Service that the money stolen at the farm was not declared upon entering the Republic and the recommendations contained in the Report of the Section 89 Independent Panel, serve to undermine the Government's efforts to combat crime and corruption; if not, what is the Government's position in this regard; if so, what are the relevant details? ★4. Ms D R Direko (ANC) to ask the Deputy President:

Noting that traditional leaders are recognised by the Constitution of the Republic of South Africa, 1996, as well as appreciating the fact that they play a critical leadership role in society, what are the details of the progress of the efforts of the Inter-Ministerial Task Team in response to matters raised by traditional leaders in respect of promoting investment and economic development in rural areas? ★5. Ms Z Majazi (IFP) to ask the Deputy President:

With regard to his role to assist the President in the roll-out of the District Development Model, (a) how does he intend to collaborate with the Department of Cooperative Governance and Traditional Affairs to promote good governance in local government and (b) how will this collaboration impact on the other spheres of government? ★6. Mrs H Denner (FF Plus) to ask the Deputy President:

Whether he has identified the Kopanong municipality as a service delivery hotspot, following the tailings dam disaster on 11 September 2022, that hit the town of Jagersfontein particularly hard, worsening the water supply of the community which they already lacked prior to the disaster, resulting in a provincial declaration of disaster, after which the Government, following the visit of President Mr MC Ramaphosa, provided water tanks, which now appears to be a wholly insufficient permanent solution; if not, why not; if so, what rapid response interventions does he intend implementing to ensure that the residents have adequate access to water that will restore their dignity?
