★144. Mr F D Xasa (ANC) to ask the Minister of Cooperative Governance and Traditional Affairs:

What (a) comprehensive support is her department providing to local government for it to be a catalyst of local economic development and job creation and (b) interventions has she found are required to strengthen the economic development role of local government? NO590E

★162. Dr L A Schreiber (DA) to ask the Minister of Public Service and Administration:

In view of recent recommendations by the Judicial Commission of Inquiry into Allegations of State Capture, Corruption and Fraud in the Public Sector including Organs of State, the guidelines of the National Framework Towards Professionalisation of the Public Sector and the provisions of the Code for Ethical Leadership in Local Government, on what grounds does she continue to defend the practice of appointing political deployees, which defies the Government's policy to professionalise public administration, given the role that the specified practice has allegedly played in facilitating state capture, corruption and service delivery failures?

- (1) Whether, in view of the fact that the 2021-22 local government audit outcomes revealed that municipalities had cumulatively accumulated R4,74 billion in fruitless and wasteful expenditure, undertaken unauthorised expenditure of R25,47 billion and wastefully and needlessly spent R1,6 billion on consultants, she intends to introduce any statutory measures, in pursuance of section 152 of the Constitution of the Republic of South Africa, 1996, that will strengthen the accountability regime and mechanisms within local government to hold failing mayors and municipal managers accountable with stringent sanctions in the event that they fail to account regularly to council; if not, why not; if so, what are the relevant details;
- (2) whether she had taken any extraordinary action with regard to the whole of the Free State, Limpopo and North West where the failure to obtain a single clean audit reflects on the extent and level to which the mechanisms and measures of accountability is broken in local government; if not, why not; if so, what actions?
