CAREER HISTORY

My career as an Intelligence Officer started in Angola as a member of uMkhonto we Sizwe under the African National Congress in 1986. I was trained and functioned as a Counter Intelligence Officer until I came back to South Africa in 1993. I amalgamated into the South African Secret Service and continued serving post 1994.

1995 – Member of the Vetting Work Group:

Post amalgamation, I was a member of the Working Group of Vetting composed of officers from the Defense Intelligence, Crime Intelligence, National Intelligence Agency (NIA) and SASS. The objective of the Working Group was to make inputs to vetting legislation and policy.

1995 – 1998: Section Head of Vetting:

As first Section Head for Vetting at the South African Secret Service since amalgamation, I lobbied against the decision to only conduct vetting on former Non Statutory Force members and not of the former National Intelligence Service (NIS). My intervention assisted where SASS did not have a vetting backlog for a very long time.

• 2005 – 2008: Manager Corporate Security (Defensive Counter Intelligence)

This position included Personnel Security, Vetting, Physical Security, Information Security, Risk Assessments, Technical Counter Surveillance Measures (TSCM), Private Interests and Gift Management. I had 98 subordinates under my leadership in my Directorate. On some of the aspects of my work, I reported straight to the Director General. I was also a member of the Adjudicating Committee on the Vetting files.

• 2008 – 2010: SARS Senior Manager for National Security

I managed the Physical Security and Risk Assessments of all 150 national SARS sites along with the Vetting of more than 15 000 SARS employees and the screening of new employees. I also managed the Declaration of Private Interests and Gift Management and Liaised with the National Intelligence Agency's General Manager for Vetting on SARS Vetting files.

• 2010 – 2014: SARS Senior Manager for Integrity Management and Promotion

I was responsible for promoting ethical leadership within the EXCO membership, Top Management as well as employees of SARS and ensuring a positive organisational culture through programs that I implemented. My work was also aimed at combating unethical risks posed by the porousness of the RSA borders, and to counter the role corruption plays in undermining the national security of the State.

2015 – 2018: Senior Manager at Armscor responsible for Personnel Security and Vetting.

I liaised with the Generals of the Defense Intelligence and formed part of the Adjudicating Panel on the Vetting Panel of the Defense Intelligence. I liaised with the CEOs of the Defense Industry to mitigate risks of the Defense Industry. I managed the Vetting of Armscor employees and those of the Defense Related Industry, including Denel and the CSIR.

• 2019 – 2021: Special Advisor to the Minister of State Security

My role was focused on the core business of Intelligence and Counter Intelligence. I was also a Chairperson of the Appeals and Adjudication Board. I was a Coordinator of a four-person team that produced a draft General Intelligence Laws Amendment Bill with a proposal of the future architecture of the Civilian Intelligence of the country.
