Concise Résumé: Prof Saths Cooper, PhD

Cooper is President of the Pan-African Psychology Union (PAPU, September 2014), Past President of the International Union of Psychological Science (IUPsyS, July 2012), a Member of the SABC Board (April 2019) and the Freedom Park Council (September 2021).

A graduate of the Universities of South Africa and Witwatersrand, and Boston University where he obtained his PhD in Clinical/Community Psychology as a Fulbright scholar in 1989, he has taught at the latter two universities and the University of the Western Cape, where he supervised doctoral graduates who are now internationally recognised leaders in their fields. He has acted as external doctoral examiner for certain universities and continues to present papers, workshops and talks extensively in South Africa (SA) and abroad, having been published in SA and overseas. He was the lead author of the current Ethical Code for Psychologists promulgated by the Health Professions Council of SA (HPCSA) in August 2006.

A close associate of the late Steve Biko and one of the founders of Black Consciousness, Cooper has played a key role in the anti-apartheid struggle in SA and internationally, the advent of democracy in SA, the unification and ascendancy of psychology and youth and community reconstruction and development during and after apartheid. He was banned and house-arrested when he was 22 years of age, and jailed for nine years. His longest period of incarceration was from 25 September 1974 to 20 December 1982, being the first accused in the seminal SASO/BPC trial in Pretoria, January 1975-December 1976. He spent over five years (1976-1982) in Robben Island in the same cell-block as former President Mandela and in 1988 was declared a 'victim of gross human rights violations' by SA's Truth and Reconciliation Commission (chaired by Archbishop Emeritus Desmond Tutu). He was a leader of the struggle against apartheid oppression and exploitation from the late sixties. After release from Robben Island in December 1982, he continued in various leadership roles when state violence was at its height. His house was petrol-bombed in 1984 and his last imprisonment was during the state of emergency in 1986, eventually being released in September. The granting of his first passport in October 1986 - valid only for the USA meant that he had missed out on much of the first term at BU, but he nevertheless completed his PhD in a record three years.

Cooper chaired the Government Task Team to Curb Child Pornography on the Internet and was appointed to the National Task Team on Correctional Services and the Ministerial Committee on Health Research Ethics. He served on the Councils of the Universities of the Witwatersrand and Durban-Westville, headed an inter-disciplinary national study into pre-pubescent rape on behalf of the National Prosecuting Authority, which reported to Cabinet, and was a member of the Press Ombudsman's Appeal Panel. He has represented SA in a variety of international forums.

The first National Director of the Institute for Multi-Party Democracy, which engaged with political parties across the spectrum in 1991 leading up to the CODESA negotiated settlement, he was the Executive Director of The Family Institute (1992-1995) that established the first national toll-free 24/7 multilingual (violence) helpline and ran numerous violence intervention, skills training, public awareness and policy advocacy programmes in the runup to SA's first democratic elections in 1994. Since 1966 (as reflected from page 23 below), he has served in a variety of local, national, regional, and international organisations of a professional, cultural, worker, student, youth, political, educational, developmental and community nature.

Elected by his peers in 1996-1998 and 2006 as President of the Psychological Society of SA (PsySSA), he was elected by PsySSA as its first Fellow in September 2002. He chaired the regulatory Professional Board for Psychology at the HPCSA in 1999 and was Vice President of the HPCSA (the first non-medical/dental professional to assume such office). He was elected a Fellow of the National Academy of Psychology - India (December 2008) and Honorary Fellow of the British (April 2013) and Irish (Dec 2013) Psychological Societies. The recipient of the IUPsyS Inaugural Achievement Against the Odds Award (January 2012), Cooper was awarded the International Association of Applied Psychology (IAAP) Award for Distinguished Professional Contributions to the Advancement of Applied Psychology (June 2014), and the American Psychological Association Award for Distinguished Contributions to the International Advancement of Psychology (December 2013), and the HPCSA Presidential Merit Award (2019).

He was the first psychologist from Africa to be elected as an officer - Vice President - of IUPsyS in 2004 and is currently its immediate Past President, the only psychologist from outside Europe and the USA to lead this prestigious international scientific and professional body. He was President of the successful 30th International Congress of Psychology (ICP), which attracted over 6000 delegates from 103 countries - the first time for this flagship event in international psychology to be held on African soil, 22-27 July 2012 in Cape Town, since the 1st ICP was held in August 1889 in Paris, France.

A Clinical Psychologist for over 35 years, Cooper was the last Vice Chancellor and Principal of the University of Durban-Westville (merged in the University of KwaZulu-Natal, and is Extraordinary Professor at the University of Pretoria.
