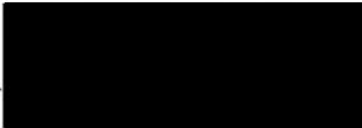

We do not pretend in this presentation to examine laws of copyright any detail. We suggest that practising copyright expects on the law as it concerns copyright.

We give in this presentation, however, a few basic facts.

The copyright owner sells to that second the copyright to use your work more than once if he wants to.

Legal there is nothing to stop you selling second South African Serial Rights –and Third and Fourth. This will protect the use of plagiarism and of course you can sell your work in any other country too.

Rights last for seven years –Which means that at the end of that time, you are free to simply of that time. You are free to simply retype previously sold work and submit it elsewhere.

You must write a completely different work each time, even if you use the same basic material , because it intend for a different market it must be in a new way. . A good idea never die.

Infact, all your work becomes your life time stock in – trade.

Copyright can be resurrected when their content once more becomes your topical, A new introduction and a general bringing up-to-date of the information, and you are ready for fresh submission.

For this reason you should be sure to keep a portfolio, and refer back to it regularly to see if there is not a pet idea of yours which could be taken off the shelf, dusted and polished ready for a new sale.

We must emphasize that this doesn't mean that you can simply send the identical work to another user.

I hope you do not offend against the laws of copyright.

There is no specific as to the laws of copyright.

Our Act merely tells us that the situation is the same as in Britain'

This means that copyright belongs to the owner for his life time, and for fifty years after his death.

Copyright extends throughout the world.

You can only lose your copyright by signing it away. It has been known for writers simply to be sent a cheque with a covering slip or stamp stating that it is in payment of copyright for (Title of the article).

Copyright is not granted to ideas, titles or systems, plots or themes, however, original and distinctive they may be.

Its aim is solely to prevent the copyright of literary, musical, drama or artistic works, sound recordings, films, TV or sound broadcasting and published editions of works.

Copyright gives protection to the form not the idea, which means that if your idea is reproduced in quite a different form, this is no infringement of copyright.

Copyright does not give a monopoly even to the form selected, since it is directed to preventing copyright, and not giving an absolute title to any particular form of words.

A person may in fact lawfully produce independently almost identical work or photograph the same object.

No formalities are required to protect your copyright-the protection exists as soon as the page of manuscript is written.

There is thus no Virtue in printed remarks such as 'copyright reserved'

We should point out that that the laws of copyright and libel in USA are different and the writer should read up the subject if it will affect him.
