1. Opening and welcoming

The Chairperson opened the meeting and welcomed all participants attending physically and virtually to the third day of hearings. He granted Ms Ebrahim the opportunity to swear in the witness of the day, Mr Johannes van Loggerenberg (Mr van Loggerenberg) who was virtually present. Mr van Loggerenberg was duly sworn in.

2. Mr van Loggerenberg

Adv. Bawa provided the background on the evidence that the witness, Mr van Loggerenberg would present to the Committee. She indicated that documents detailing the timeline of the relevant events had been shared with the Public Protector's legal team and the members of the Committee. She highlighted that Mr Pravin Gordan had taken the Public Protector's report on the SARS Investigative Unit on review on 5 July 2019. Adv. Bawa sited various paragraphs in relevant Constitutional cases, reviews and appeals, including the Constitutional Court case of *Gordhan v Public Protector and Others (48521/19) [2019] ZAGPPHC 311; [2019] 3 All SA 743 (GP) (29 July 2019),* to further detail the background of the basis of the evidence that was to be presented to the Committee.

Adv. Bawa interacted with the witness, Mr van Loggerenberg, and addressed the content of his affidavit. Mr van Loggerenberg detailed the circumstances under which fellow staff members and himself found themselves in the duration of his employment at SARS Investigative Unit. He shared details of his professional background and events that led to his decision to submit a complaint at the Public Protector's Office in 2016. Mr van Loggerenberg submitted the required evidence to the Public Protector's Office and testified that he received acknowledgement of receipt on 16 August 2016. Moreover, he testified that the Public Protector ignored the evidence that he provided for the investigation.

Adv. Bawa indicated that a recording would be played for the Committee to listen to. On behalf of the Public Protector, Adv. Mpofu indicated that his team had not been able to open the recording of the meeting in question. Adv. Bawa explained that the recording had been available from 30 June 2022, and that she had offered to forward the recording to Adv. Mpofu and his team if they had any trouble accessing it. The recording of the meeting between the Public Protector, Adv. Mkhwebane, and other participants of the Intelligence Agency regarding the report on the SARS "Rogue Unit" investigation was played for the Committee.

Thereafter, Adv. Bawa sought confirmation from Mr van Loggerenberg regarding the content of the Public Protector's Report and submissions to subsequent cases that ultimately resulted in the reports being set aside on review by the courts.

Mr van Loggerenberg was allowed to leave the platform. The Committee was informed that a further evidence presentation and cross-examination from the Public Protector's legal representatives would resume on the following day.

Adv. Bawa provided the Committee members with a detailed timeline of events with reference to the case of *Gordhan v Public Protector and Others (48521/19) [2019] ZAGPPHC 311; [2019] 3 All SA 743 (GP) (29 July 2019)* and two other cases that were before the courts, subsequent to the Public Protector's Report.

3. Closing remarks

The Chairperson granted Adv. Bawa the opportunity to address the issue of the Public Protector's inability to access her emails. Adv Bawa indicated that she had contacted the Acting Public Protector, Adv. Gcaleka regarding the matter. She explained to the Committee that she received two letters that had been addressed to the suspended Public Protector, Adv. Mkhwebane regarding the issue of access to emails.

On behalf of Adv. Mkhwebane, Adv. Mpofu questioned the appropriateness of sharing a personal letter addressed to Adv. Mkhwebane with the Committee. He reported to the Committee that the letters had not been shared with himself and the Public Protector's legal team, and further raised concerns about the letter possibly containing information that may necessitate Adv. Mpofu be privy to prior to the contents of the letter being shared with the Committee.

Adv. Bawa indicated that the first letter, dated 10 June 2022, was attached to one of the court judgements in question, and was therefore in the public domain. She further assured the Public Protector that as a privacy measure she would only share the contents of the last paragraph of the second letter in question. Adv. Bawa presented the content of the first letter wherein the Acting Public Prosecutor indicated that the office was informed of Adv. Mkhwebane's suspension on 9 June 2022, and read the last paragraph of the second letter. She highlighted that the Acting Public Protector had indicated that access had been granted to the Public Protector and that IT services could be utilised to assist if the problem persisted.

Adv. Mpofu reported that even after the second letter was received, Adv. Mkhwebane could still not access her emails. He then expressed gratitude to Adv. Bawa, the Evidence Leaders and the Committee for the assistance and urgent attention to the matter.

The Chairperson reminded members and all present that the testimony by Mr van Loggerenberg will resume on Thursday, 14 July 2022.
