Objectives of the Study Tour

The Rules Committee has been considering how best the Assembly can enhance its oversight over Vote 1 – The Presidency, mindful of the unique role of the Presidency. This matter was referred to the Subcommittee on Review of Assembly Rules (the Subcommittee).

The Subcommittee requested the Parliamentary Budget Office (PBO) to analyze Vote 1 to determine which aspects of the Vote were currently not subjected to scrutiny.

The PBO concluded that Parliament should strengthen its oversight, but that further research would be beneficial. In so doing, the PBO reflected on international practices including those employed in the UK to oversee the Office of the Prime Minister.

Objectives cont...

In April 2023, the Rules Committee agreed that it would be instructive for members to undertake a study tour to engage counterparts in the UK. The delegation is comprised of -

The delegation will be supported by the Secretary to the National Assembly and three other officials including the Director of the PBO.

Objectives cont...

The delegation will seek to engage political representatives and procedural experts from Westminster, as well as relevant institutions in order to establish, among other things -

- The procedures and conventions relating to the oversight mandate of the `Commons and the accounting responsibilities of the Prime Minister;
- The structure/s employed to scrutinize the Office of the Prime Minister within Westminster; and
- Any procedural challenges encountered by the Commons and its committees in exercising oversight over the Office.

Objectives cont...

In addition, members also identified a number of other subjects to be pursued. These include -

- Procedures followed in conducting committee inquiries;
- Procedures and processes related to the passage of government budgets, as well as the support provided to committees to analyze budgets;
- Public participation in law-making; and
- The mandate and role of the Environmental Audit Committee and the Climate Change Committee (Commission).

A briefing paper has been prepared which introduces the subjects referred to above. The South African High Commission has also provided a profile for the UK.

Programme of the Study Tour for 18 July

A detailed programme has been developed by Parliament in collaboration with Westminster. Engagements will cover three days from the 18th- 20th of July 2023.

Members will be hosted by Westminster on the 18th (refer to attached programme). Members will hold meetings with the –

- Procedures (Rules) Committee;
- Financial Scrutiny Unit (on the budget process);
- Programme Director of the Parliamentary Commonwealth Association
- Liaison Committee; and
- The Clerks of the Grand Committee and Environmental Committees.

Programme of the Study Tour for 19 July

Meetings on the 19th of July will be held outside of Westminster. Engagements will be held with -

- The Institute for Government (a non-profit organization that works with Government and monitors Parliament)
- Sir Malcolm Jack (the former Clerk/Secretary to the House of Commons).

Both the Institute and the former Clerk of the House of Commons will be able to provide an outside assessment of the efficacy of the House of Commons in performing oversight and specifically over the Head of Government.

We are also attempting to confirm a meeting with the Climate Change Committee (Commission) for the morning, before the Institute for Government.

Programme of the Study Tour for 20 July

Meetings have been arranged in the morning of the 20th with -

- Institute for Fiscal Studies (IFS)
- Office of Budget Responsibility (OBR)

The IFS is an economic research institute which specializes in taxation and public policy. It produces both academic and policy-related findings.

The OBR is the UK's official independent economic and fiscal forecaster (similar to the PBO).

These institutions will be able to expand on the information provided on budget proceedings by the relevant parties in the UK Parliament.
