Deputy Chairperson

- Assist the Chairperson in the political management
- Act as Chairperson in the absence of Chairperson
- Chair proceedings of the House
- Custodian of Rules
- Sectoral Parliaments

House Chairperson: Committees

- Ensure the programming of committee activities
- Ensure and monitor the provision of administrative support to committees
- Ensure planning by Committees
- Ensure the compilation of the programmes of Committees
- Ensure compilation of budgets of Committees in line with their strategic plans



House Chairperson: Committees

- Co-ordinate the activities of Select Committees
- Convene and chair the meetings of the Committee of Chairpersons
- Ensure the implementation of policies relating to Members'
 Facilities
- Monitor and report on policies on ICT, artwork management,
 library and exhibitions



House Chairperson: International Relations

- Responsible for Members Interests and Facilities
- Monitor and report on the needs of members with disabilities
- Monitor and report on the implementation of policy in relation to former MP's facilities
- Monitor support to members and advise on their needs



Chief Whip

- Assist the Presiding Officers with political management of the institution
- Enhance the relationship between political parties and provincial delegations
- Assist the Presiding Officers to maintain discipline across party and provincial delegation lines
- In consultation with the Presiding Officers, co-ordinate the business of the house



Chief Whip


- Prepare the speakers' list

- Liaise with the office of the Leader of Government Business in respect of the attendance of members of the Executive to the house




