Honourable NN Mapisa-Nqakula, MP - Speaker of The National Assembly, Parliament of The Republic of SA

The Hon. Nosiviwe Noluthando Mapisa-Nqakula, MP is the Speaker of the National Assembly in the Parliament of the Republic of South Africa. She was elected Speaker of the House (National Assembly) on Thursday 19 August 2021. She previously served as the Minister of Defense and Military Veterans (2012-2021); Minister of Correctional Service (2009-2012); Minister of Home Affairs (2004-2009). Deputy Minister Home Affairs (2002-2004) within the South African government.

Purpose of Webinar

Christine Muhigana has 33 years of experience within the United Nations. She took up her role as UNICEF Representative in South Africa in September 2020. She was previously the UNICEF Representative in the Central African Republic (CAR) for three years, from 2017 to 2020, and prior to that, she served as UNICEF Deputy Regional Director for the West and Central Africa region based in Dakar, Senegal from 2013 to 2017. From 2008 to 2013, She was the Deputy Director of the Office of the Secretary of the Executive Board of UNICEF in New York. Christine worked in many African countries, including Cameroon, Cape Verde, Côte d'Ivoire, Sénégal and visited many more in her regional and headquarters advisory functions. She holds a master's degree in Political Science and International Relations and a Master's degree in Maritime and Air Law from the Université Libre de Bruxelles in Belgium.

Lori has an Honours in Anthropology and a Postgraduate Diploma in Higher Education. She specialises in making complex ideas accessible to a wider audience and is interested in engaged scholarship that harnesses the power and resources of the university to promote children's rights, health and optimal development.

Session 3. Implications of the data

Mr. David Chabalala, Acting Chief Director Office of the Rights of the Child, Department of Social Development

David Chabalala is currently the Acting Chief Director, Office on the Rights of the Child at the National Department of Social Development. Post Graduate on Development Studies with UNISA. Before joining government, he was involved in the trade union movements as a worker representative and organiser for the National Union of Metal Workers of South Africa (NUMSA) and involved in different COSATU structures at local, regional and national levels. He attended a number of courses on Labour Relations which amongst others, were offered by Wits and the International Labour Organisation (ILO). He joined government in the early years of the South African democratic dispensation in 1996. He started at the Department of Labour National office where he was responsible for negotiations towards the promulgation of the Basic Conditions of Employment Act. He spearheads the national agenda on child labour, including effective participation at national and international levels during the negotiations on the drafting of the Convention on the Elimination of the Worst Forms of Child Labour. David Chabalala participated in the presentation of the first South African country report to the UN in 2000, Geneva. He joined the Presidency (Office on the Rights of the Child) in 2005 where he was responsible for ensuring implementation of national agenda on the elimination of child labour as it was one of the priorities. Presently David Chabalala is responsible for the development and implementation of the National Plan of Action for Children, which involves ensuring the strengthening of institutional mechanisms and capacity development, Child Rights Advocacy, Monitoring, Evaluation and Reporting obligations at national, regional and international levels.

Closing Remarks

Honourable Nkosiyakhe Amos Masondo, Chairperson of the National Council of Provinces, Parliament of The Republic of SA

Mr. Nkosiyakhe Amos Masondo is the Chairperson of the National Council of Provinces, one of the two Houses of the Parliament of the Republic of South Africa. He was elected to this position after May 2019 National general elections in South Africa. He was born on 21 April 1953 in Louwsburg, about 50 kilometers from Vryheid, and grew up in Soweto (Johannesburg).

In the early 1970's he became a member of both NAYO (National Youth Origination) as well as SASM (South African Student Movement). He was imprisoned on Robben Island from 1976 to 1981 for his participation in the liberation struggle. He was again detained under the emergency regulations from June 1985 to March 1986 and again from July 1986 to 1989. He served as member and leader of the Soweto Civic Association.

He is a founding member of the United Democratic Front. On his release in 1989, he became regional secretary for the Congress of South African Trade Unions (Cosatu), the trade union umbrella organisation and the African National Congress' regional election coordinator. In 2001 he was elected as a Member of the Gauteng Legislature and was subsequently elected to serve as Mayor of Johannesburg. He was the Mayor of the City of Johannesburg from 2001 to 2011 and successfully led the process of deepening and unifying the Local Municipality into a greater Metropolitan Democratic Local Government. He later served in the headquarters of the African National Congress at the President's Office. He became a Member of Parliament, serving in the National Assembly, from May 2014 until May 2019. In the National Assembly, he was appointed to the Joint Committee on Ethics and to the Portfolio Committee on the Financial Management of Parliament and on the Ad Hoc Committee to nominate a person for appointment as the Public Protector. He has been awarded many awards and recognised for various achievements on governance.
