#### **IMPACT OF LOOTING**

### FREE STATE PROVINCE

The following factors could have an impact on the provincial social and economic environment:

#### Supply chain disruptions

- Food shortages (damage to transport infrastructure had caused food shortages, leading to queues outside grocery stores, and prevented harvesting and distribution of fresh produce)
- Fuel shortages (prohibitions on the citizens' ability to buy fuel in portable containers and canisters, citing concerns that stockpiling would exacerbate the situation)
- Medical supply shortages (Clicks and Dis-Chem, the two largest pharmaceutical retailers in South Africa, reported supply disruptions due to looting. The provision of clinical medicine to hospitals was also disrupted)
- Financial
  - The South African rand weakened as much as 2% on 12 July, the most it has since 25 February 2021
- Suspension of services
  - Many of South Africa's banks had to shut down their ATMs, branches, and other facilities in response to the unrest
- COVID-19 vaccine rollout crisis (Following the impact of the looting and destruction to property, multiple Covid-19 vaccine rollout sites were closed to prevent looting and property destruction)

#### **MALUTI A PHOFUNG SEZ**

- General and opportunistic vandalism of critical infrastructure at MAP SEZ which is located on the N5 and also close to Harrismith:
- Vandalizing of electrical sub-stations
- Theft and vandalizing of perimeter lights
- Electrical cables that were reserved for bulk electrical works were stolen.
- Disruption to investor manufacturing productivity, leading to loss of revenue and unnecessary expenditure on alternative measures of supply of electricity e.g. generators.
- During the solar street light vandalism, the park perimeter Clearview fence was cut and left with open holes across the N5 road.
- Three MAPSEZ guard houses at the gate were vandalized.
- New CCTV screens were stolen, air conditioners were vandalized and recording systems were stolen.
- Surveillance cameras were also stolen and the aluminium glass doors were vandalized at the three gate houses.
- Service delivery protests in the Maluti-a-Phofung area.
- No loss of life was reported.

#### MALUTI A PHOFUNG SEZ

Below are the cost estimates for the repairs to the vandalized infrastructure at MAPSEZ:

ltem	Descriptions	Estimated costs
1	Replacement of solar street lights	R 20 000 000
2	Replacement of Electrical Mini-substations	R 12 000 000
3	Revamp of vandalized green land substation	R 4 500 000
4	Electrical Cable Theft	R 3 000 000
5	Repairs to vandalized 1C substation	R 400 000
6	Vandalized Gate houses	R 350 000
7	Substations temporary repairs	R 350 000
8	Repairs to parameter fence	R 1700 000
9	High voltage electrical cable	R 18 000 000

#### FREE STATE DEVELOPMENT CORPORATION PROPERTIES

#### Mangaung Metropolitan Municipality:

- Only one business was looted.
- Thabo Mofutsanyane:
  - 15 businesses were looted.
- No loss of life was reported.
- Police acted swiftly in both instances such that there were minimal losses

#### **PRIVATE SECTOR BUSINESSES**

- The Free State was fortunate in that no businesses, other than that reported in the SEZ and FDC, reported any direct damage due to looting.
- Businesses however experienced financial losses due to disruptions in supply chain processes in the aftermath of the riots.
- A lot of companies who relied on supplies from Durban had to find alternative suppliers elsewhere
- Tourism was also affected as the these looting incidents has a negative impact on 'Brand South Africa'. Businesses within the tourism value chain were most affected as the travelling for leisure was negatively affected.

#### **MEASURES TO MITIGATE THE IMPACT**





#### **MITIGATION MEASURES**

- Deployment of SANDF during early stages.
- Higher SAPS visibility.
- Support via DESTEA Incentives were primarily targeted at supporting businesses as they recover from the negative impact of restrictive measures meant to minimise the spread of the COVID-19 virus:
  - Enterprise Support Incentives
  - Industrialization Support Incentives
  - Business Development and Support
- The department and its entities have been working closely with sector departments such as NDT, DSBD and the dtic on the roll-out of intervention measures.
- In addition, the department and its entities are collaborating with DFIs (IDC, SEFA, NEF) on ensuring that Free State businesses are able to access incentives offered by the DFIs
- The department has also established both the Provincial and District LED forums as well as with Businesses Chambers as part of measures to support the economic recovery.
- The department and its marketing agency has launched a "Travel Differently' campaign to market the Free State as a tourism destination of choice
