Honourable Dr. N C Dlamini-Zuma, MP

Honourable Dr. N C Dlamini-Zuma, MP is the Minister of Cooperative Governance and Traditional Affairs. She holds a BSc degree in Zoology and Botany from University of Zululand 1971; MB ChB from University of Bristol and a Diploma in Tropical Child Health from School of Tropical Medicine, University of Liverpool.

Honourable Dr. N C Dlamini-Zuma has a pivotal and pioneering role in the leadership of various government departments, research organisations and international organization. She served as a Minister of Health from 1994 to 1999, Minister of Foreign Affairs from 17 June 1999 to 10 May 2009, Minister of Home Affairs of the Republic of South Africa from 11 May 2009 until Sept 2012, Minister in The Presidency: Planning, Monitoring and Evaluation from 27 February 2018 to 25 May 2019 and Minister of Cooperative Governance and Traditional Affairs from 30 May 2019.

Dr Dlamini Zuma has also served as the President of the United Nations World Conference Against Racism (WCAR); President of the Ministers' Council for the United Nations World Summit on Sustainable Development (WSSD) and led a number of peace initiatives to DRC, Comoros, Lesotho and many others. She is a former Chairperson of the African Union (AU) Executive Council of Ministers, during South Africa's tenures as AU Chairperson.
