


# No one can claim innocence when the AG makes a critical observation about serious weaknesses in the financial management of local government – NCOP Chairperson

In his opening remarks on the occasion of the opening of the National Council of Provinces' (NCOP's) 2020 Local Government Week, the Chairperson of the NCOP,

Mr Amos Masondo, prefaced his remarks on highlighting the constitutional mandate of the NCOP. He said: "The constitutional mandate

of the NCOP is to ensure that the provincial interests are taken into account in the national sphere of government.

The House is also charged with the task of making sure that, through organised local government, space is provided for the participation of local government representatives in its proceedings."

He added: "Over the years we have come to realise the importance of this arrangement. As such, there has been agreement that their non-voting status should be changed to enable them to vote in the NCOP, and thus form an integral part of the decision-making process. Some would argue that we still need to consider this recommendation and to find innovative ways of ensuring that it becomes a reality."

Mr Masondo said the importance of working together to build coherence in support of local government, is foregrounded by the location of municipalities in the cooperative government scheme. In this regard, he said section 154 (1) of the Constitution clearly stipulates that the national government and provincial governments, by legislative and other measures, must support and strengthen the capacity of municipalities to manage their own affairs, to exercise their powers and to perform their functions.

It is important to note that in designing these measures, national and provincial governments are required to consult the municipalities.

Specifically, section 154(2) of the Constitution provides as follows:

"Draft national or

provincial legislation that affects the status, institutions, powers or functions of local government must be published for public comment before it is introduced in Parliament or in a provincial legislature, in a manner that allows organised local government, municipalities and other interested persons an opportunity to make representations with regard to the draft legislation."

Given its character and design, Mr Masondo said: "The NCOP is better placed to facilitate cooperative government in a manner that allows local government to receive the necessary support in order to be able to perform its functions effectively."

Based on that, he said: "We therefore cannot, for lack of a better expression, claim innocence, when the Auditor-General (AG) makes the critical observation that over the past three years there have been serious weaknesses in the financial management of local government."

# NCOP is the anchor of the system of cooperative governance

Another key strategic mechanism initiated by the NCOP (National Council of Provinces) for the broadening and diversification of the means of linkage with the provinces, was the Provincial Week Programme. The programme was initiated in the 2nd Parliament during the chairpersonship tenure of Dr Naledi Pandor, to solicit provincial interests and to ensure that provincial delegates to the NCOP keep abreast of developments, as well as service delivery challenges facing their provinces.

Asked by the Provincial Week News Bulletin writers to share his expectations about the impact of the 2020 programme on the accountability of the

provincial and local stewards of service delivery, the NCOP's House Chairperson responsible for committees, Mr Jomo Nyambi, said: "The onset of the Provincial Week brings with it a lot of excitement as we look forward to a week of intensive engagements to improve accountability within municipalities in our different provinces." He described the programme as an important oversight tool at "our disposal". He said the delegations go into the programme armed with resolutions from the 2020 Local Government Week and the Auditor-General's Municipal Audit outcomes with a view to strengthening governance.


