INdlu yoWiso-mthetho yeSizwe ngokuvumelana neBhunga lamaPhondo leSizwe iye yagunyazisa uQwalaselo ngokuTsha loMgaqo-siseko yiKomiti ukuze:

- (a) iqwalasele ngokutsha icandelo 25 loMgaqo-siseko kwakunye namanye amacandelo apho kuyimfuneko, ukwenzela ukuba urhulumente abe nokuhlutha umhlaba ngaphandle kwembuyekezo elungiselela uluntu;
- (b) iphakamise ufakelo-zihlomelo kuMgaqo-siseko apho oku kuyimfuneko khona ngokubhekiselele kuhlobo lwenkqubo yomiwo-mhlaba yexesha elizayo eyimfuneko.

Njengexalenye yokusebenzisa igunya eliqulethwe kuMgaqo-siseko lokulungiselela intatho-nxaxheba yoluntu, iKomiti icela ukuba kungeniswe iziphakamiso ezibhaliweyo ezisuka kubo bonke abachaphazekayo ngokubhekiselele kwimfuneko kwakunye neendlela zokuhluthwa komhlaba ngaphandle kwembuyekezo.

Ngaphandle kweziphakamiso ezibhaliweyo, nceda ubonakalise umdla wakho wokwenza ingcaciso yomlomo kwiKomiti.
