INdlu yesiBethamthetho seNarha ngokubambisana nomKhandlu weNarha oNgamele iimFunda zinikele umlayo iKomidi eBuyekeza umThethosisekelo bona:

- (a) zibuyekeze isigaba sama-25 somThethosisekelo kunye nezinye iingaba lapho kutlhogeka khona, bona yenze kukghonakale ukuthi umbuso uthathe inarha ngokuya kwerhuluphelo lomphakathi ngaphandle kokuncephezela abanikazi;
- (b) ihlongoze iinkhibelelo zomthethomlingwa ezitlhogekako lakufanele khona malungana negomuso lesikhathi esifunekako sokuhlala kwabantu enarheni.

Njengencenye yokwenza umsebenzi ngokuya kwemfuno zomthethosisekelo bona kukhambiswe ukuzibandakanya komphakathi, iKomidi imema iimphakamiso ezitloliweko ezivela kizozoke iinhlango ezibandakanyekako ekutlhogekeni begodu neenkambisweni zokuthathwa kwenarha ngaphandle kwesincephezelo.

Ukungezelela ekuthunyelweni kweemphakamiso ezitloliweko, sibawa usazise nangabe unerhuluphelo lokwenza isiphakamiso sakho ngokuzikhulumela eKomidini.
