- uqhubeke uhlinzekele ukufakaziswa kwezinto ezithile nge-affidavithi;
- uphoqelele izibopho zokuthi kubikwe amacala enziwa nge-inthanethi;
- uhlinzekele ukwandisa amandla okwakha; futhi
- uhlinzekele ukuthi abaHoli bezwe bangene ezivumelwaneni naMazwe angaphandle ukukhuthaza izinyathelo eziqondiswe ekutholeni, ukuvimba, ukunciphisa kanye nokuphenywa kwamacala enziwa nge-inthanethi kanye nezinye izinto.
