

**IMEMORANDAM NGEENJONGO ZOMTHETHO OYILWAYO
WOKUBONELELWA NGEZIMALI KWEMIBUTHO YEZOPOLITIKO,
WOWAMA-2017**

1. IINJONGO ZOMTHETHO OYILWAYO

Ukubonelelwa ngezimali ngurhulumente kwemibutho yezopolitiko kwizindlu zowiso-mthetho zesizwe nezephondo kunikezelwa ngokoMthetho wokuBonelelwa ngeziMali kweMibutho yezoPolitiko eMelweyo, onguNombl.103 wowe-1997 (“uMthetho woBonelelo ngeziMali”).

Ngowe-6 kuCanzibe wowama-2017 iNdlu yoWiso-Mthetho yesizwe yagqiba ekubeni imisele ikomiti yexeshana, ngokoMthetho weNdlu yoWiso-Mthetho yeSizwe wama-253 (1)(a), ukuba–

“ibuze kwaye yenze izindululo ngokubonelelwa ngezimali kwemibutho yezopolitiko emelweyo kwizindlu zowiso-mthetho zesizwe nezamaphondo eMzantsi Afrika ngokombono wokuveza into yokuhlomela lo mthetho xa kukho imfuneko kwaye, ngokwenza oko, iqwalasele –

- Indlela yobonelelo ngezimali lukarhulumente nolwabucala kwimibutho yezopolitiko; kunye
- Nemfuno kunye neendlela ezinokubakhona zokulawula ubonelelo ngemali lwabucala kuzo zonke iindlela zako kunye namaqumrhu otyalo-mali angawemibutho yezopolitiko[;]”.

IKomiti yeXeshana yabiza uluntu ukuba lufake iziphakamiso zalo malunga nendlela uMthetho wokuBonelelwa ngeziMali kweMibutho yezoPolitiko eMelweyo, onguNombl 103 wowe-1997 ongakuqinisekisa ngako ukuba kuvunyelwe ingcaciso emandla ngokwendlela imibutho yezopolitiko ebonelelwa ngayo ngezimali ukuze kuqinisekiswa ngokusebenza kwayo ngokukuko. Le Komiti yafumana uludwe lwezimvo ezibhaliweyo ezilishumi elinesithandathu yaza yaqhubeka yamema bonke abo babefake izimvo ukuba benze izimvo zabo ngomlomo ngendlela lendibano yovakaliso-zomvo eyayibanjwe ukususela ngowe-15 ukuya kowe-17 kweyeThupha yowama-2017.

2. INGXOXO YOMTHETHO OYILWAYO

2.1. INgabula-zigcawu yoMthetho oYilwayo woBonelelo ngeziMali kwiMibutho yezoPolitiko, wowama-2017 (“uMthetho oYilwayo”) ufuna ukuchaphazela imfuno yokuba kusebenze isibophelelo somgaqo-siseko esivezwe ngokwecandelo lama-236 loMgaqo-siseko weRiphabhliki yoMzantsi Afrika, yowe-1996 (“uMgaqo-siseko”). Kwakhona ifuna ukuchaphazela igunya lowiso-mthetho lendibano yePalamente ngokwecandelo lama-44 ukuba ipasise umthetho onento yokwenza nemiba enje ngokulawula ubonelelo ngezimali lwabucala kwimibutho yezopolitiko.

2.2. ISoloty loku-1 loMthetho oYilwayo liquka iingcaciso.

2.3. ISoloty lesi-2 loMthetho oYilwayo ufuna ukuba kumiselwe iNgxowa-mali yeMibutho yezoPolitiko eMelweyo ngenjongo yokukhuthaza ulawulo lwentando yesinzi lwemibutho ngemibutho. Le ngxowa-mali inikezela ngobonelelo ngemali kwimibutho yezopolitiko ethatha inxaxheba ePalamente nakwizindlu zowiso-mthetho zamaphondo. Ifumana imali ngemali eyabelwa yiPalamente, imali ehlawulwa ngokwesoloty le-18 kunye nenzala efunyanwa kwimali etyalwe ngokwesoloty le-4(3).

Le ngxowa-mali kukholelwa ukuba yingxowa-mali ekhoyo eyamiselwa phantsi koMthetho wokuBonelelwa ngeziMali kweMibutho yezoPolitiko eMelweyo, onguNombl 103 wowe-1997. Jonga kwisoloty lama-24 malunga nalo mba.

2.4. Kwisoloty lesi-3 lalo Mthetho uYilwayo kucetyiswe ukuba iNgxowa-mali yoLawulo lweNtando yesininzi yeMibutho ngemibutho imiselwe ukuze inikezele ngemithombo yabucala yezimali kwimibutho yezopolitiko ethatha inxaxheba ePalamente nakwizindlu zowiso-mthetho zephondo. Eli soloty kwakhona alukuvumeli ukubonelelwa ngemali evela kumacandelo kaRhulumente nakoohulumente bamanye amazwe okanye ii-arhente.

2.5. Isoloty le-4 loMthetho oYilwayo phakathi kwezinye izinto licebisa ukuba iKomishoni kufuneka ifake yonke imali emisiweyo kwityala lengxowa-mali nganye kwi-akhawunti yebhanki eyahlukileyo kwaye ingatyala imali engazufunwa ngokukhawuleza ekubeni

yabelwe imibutho yezopolitiko kunye noKopolotyeni woTyalo-mali kaRhulumente.

- 2.6. Isolotya lesi-5 loMthetho oYilwayo unento yokwenza nolawulo lweengxowa-mali ezimbini. Licebisa ukuba igosa lolonyulo elikhulu leKomishoni yoLonyulo eziMeleyo (“iKomishoni”) libe lilo elinoxanduva lokuphendula kunye negosa lesigqeba elikhulu leengxowa-mali zombini.
- 2.7. Isolotya le-6 loMthetho oYilwayo phakathi kwezinye izinto licebisa ngokulawula ulwabelo kunye nokuhlalulwa kwemali kwimibutho yezopolitiko. Eli solotya linikezela ukuba ulwabelo kufuneka lwenziwe ngokwendlela eyalelweyo ebhekiselele:
- (a) kulwabelo olulinganayo kuqwalaselwe:
 - (i) isixa esimisiweyo sesabelo esincinci kuyo yonke imibutho yezopolitiko emelwe kwiNdlu yoWiso-Mthetho yeSizwe kunye nezindlu zowiso-mthetho zamaphondo; okanye
 - (ii) isikali ekuthathwe umlinganiselo waso sokumelwa kwisabelo semibutho yezopolitiko enabameli abakwiNdlu yoWiso-Mthetho yeSizwe okanye izindlu zowiso-mthetho zamaphondo; kunye
 - (b) nesabelo sesixa-mali kuqwalaselwe ubudlelwane bokuba inani labameli bemibutho yezopolitiko kwiNdlu yoWiso-Mthetho yeSizwe kunye nezindlu zowiso-mthetho zamaphondo buveza inani lezitulo kwezi zindlu zowiso-mthetho.

Eli solotya kwakhona licebisa ukuba iKomishoni kufuneka ihlawule imali eyabelweyo ngamaxesha ayalelweyo.

- 2.8. Isolotya lesi-7 loMthetho oYilwayo uzibeka zonke iinjongo nendlela emayisetyenziswe ngayo imali evela kwingxowa-mali. Eli solotya lwakhona liyayibeka kakuhle into yokuba zeziphi na izinto engafanelekanga isetyenziselwe zona le mali.
- 2.9. Isolotya lesi-8 loMthetho oYilwayo ufuna ukulawula imali esisibonelelo ethe ngqo yemibutho yezopolitiko kwaye uqulethe iinkcazelo ezifanelekileyo kuphela ukuba zicetyiswe kwiSahluko sesi-3.
- 2.10. Isolotya le-9 loMthetho oYilwayo ufuna ukuba kungavunyelwa iminikelo eyenziwe

ngokuthe ngqo kwimibutho yezopolitiko evela koovimba abathile.

- 2.11. Isoloty le-10 loMthetho oYilwayo ufuna ukulawula ukuvezwa kweminikelo eyenziwe ngokuthe ngqo kwimibutho yezopolitiko. Linikezela ngokuba kuvezwe yonke iminikelo engaphezulu kwesixa-mali eziyalelweyo ngenkqubo kunye nendlela eyalelweyo. Likwanikezela nangexesha apho iKomishoni kufuneka iveze ezo nkukacha.
- 2.12. Isoloty le-11 loMthetho oYilwayo awuluvumeli ubonelelo ngemali oluthe ngqo lwamalungu kuwo nawuphi na umbutho wezopolitiko.
- 2.13. Isoloty le-12 loMthetho oYilwayo unento yokwenza neemfuno kwimibutho yezopolitiko ukuba ixhase iKomishoni ngenkcukacha ezithile eziyalelweyo kunye namaxwebhu.
- 2.14. Isoloty le-13 loMthetho oYilwayo ufuna ukulawula indlela imibutho yezopolitiko emelweyo emayiphendule ngayo ngemali ehlawulwe kuyo evela kwiingxowa-mali.
- 2.15. Isoloty le-14 loMthetho oYilwayo unikezela ngendlela iKomishoni ekufuneka isebenze ngayo malunga nemali engasetyenziswanga ekupheleni konyaka-mali. Eli soloty kwakhona linikezela ngendlela emakusetyenzwe ngayo ngemali engasetyenziswanga xa ithe iPalamente okanye izindlu zowiso-mthetho zavalwa.
- 2.16. Isoloty le-15 loMthetho oYilwayo unento yokwenza namagunya okuvavanya nawokongamela eKomishoni.
- 2.17. Isoloty le-16 loMthetho oYilwayo ubonelela iKomishoni ngegunya lokukhupha isikhokelo kumbutho wezopolitiko ukuze ungakwazi ukunyanzelisa ugunyaziso.
- 2.18. Isoloty le-17 woMthetho oYilwayo ubonelela iKomishoni ngegunya lokurhoxisa intlawulo yemali phantsi kweemeko ezithile.
- 2.19. Isoloty le-18 loMthetho oYilwayo ubonelela iKomishoni ngegunya lokuhlawula imali eyamkelwe ngokungekho mthethweni okanye esetyenziswe yimibutho yezopolitiko.

- 2.20. Isolotyala le-19 loMthetho oYilwayo ufuna ukubonelela iKomishoni ngegunya lokunyanzelisa izohlwayo zolawulo ngokubhekiselele kukungathobeli okanye ukungathobeli ngokuphinda-phindeneyo.
- 2.21. Isolotyala lama-20 linento yokwenza namalungelo akhe nawuphi na umntu okuba ahlaziye okanye abhenele nasiphi na isigqibo seKomishoni ngokoMthetho oYilwayo. Kwakhona ufuna ukumisela iNkundla yoLonyulo njengenkundla enobulungisa obukhethekileyo ukuba umamele kwaye imisele naluphi na uhlaziyo okanye isibhelo esibhekiselele kwisigqibo seKomishoni.
- 2.22. Isolotyala lama-21 loMthetho oYilwayo unikezela ngokuba kwenziwe ingxelo yiKomishoni ePalamente.
- 2.23. Isolotyala lama-22 loMthetho oYilwayo ufuna ukucebisa ukuba izindlu zowiso-mthetho zingabonelela-ngemali kuphela imibutho yezopolitiko ngokwecandelo 57(2) nele-116(2) loMgaqo-siseko, ngokulandelelana kwawo. Kwakhona aliwavumeli amabhunga oomasipala ukuba abonelele ngemali imibutho yezopolitiko kunye nabantu abazimeleyo.
- 2.24. Isolotyala lama-23 loMthetho oYilwayo linikezela ngemiba iKomishoni enokwenza imithetho ngayo malunga nokuvunyelwa kweNdlu yoWiso-mthetho yeSizwe ngokubhekiselele kwimiba ethile.
- 2.25. Isolotyala lama-24 loMthetho oYilwayo unikezela ngokubhangiswa koMthetho we-103 wowe-1997, uyekwe njengoko kunikezelwe kwizibonelelo zotshintsho kweli solotyala, nto leyo ibandakanya uqwalaselo lwemiqathango ephantsi koMthetho we-103 wowe-1997 ukuba ibe yimiqathango eyenziwe phantsi koMthetho oYilwayo.
- 2.26. Icandelo lama-25 loMthetho oYilwayo liquka isihloko esifutshane kunye nesiqalo.

5.2. Ikomiti inoluvo lokuba akuyomfuneko ukubhekiselela kuMthetho oYilwayo kwiNdlu yeeNkokheli zeMveli ngokwecandelo le-18(1)(a) loMthetho wobuNkokheli beMveli neNkqubo-sikhokelo yoLawulo, wowama-2003 (uMthetho onguNomb. 41 wowama-2003), njengoko ungaziquki izibonelelo eziphathelele kumthetho wesintu woluntu lwemveli.
